House Rules!

Pharmacists, pharmacy technicians and their premises are regulated by an organisation called the General Pharmaceutical Council. This organisation is responsible for setting and maintaining the conduct, ethics, standards and education of pharmacy professionals in their registered pharmacies. We have to pay a fee for this pleasure.

As with other professions, the regulatory body looks closely at the conduct of the registrant, with an emphasis on their professional conduct but with the authority to make judgements on their conduct outside of work too. This is important, as being a part-time stripper or serial killer wouldn't give the required impression of our profession but they did still allow you a little leeway off the premises. Before I get complaints, I am not equating stripping with murder.

There has been a recent decision to implement new standards where they intend to enforce the same standards at all times rather than just during working hours. This has caused anger amongst the ranks and led to the decision being described as 'Orwellian'. The judge has gone away to consider the evidence that was presented during the High Court case back in March.

I followed the case closely via a reporter from the pharmacy press and my feelings went from slightly agitated right through to incandescent rage. There was a lot of talking but the take-home points from the case were:

- The government QC sniped that pharmacies pretty much sold shampoos and sandwiches. It's a good job he doesn't come in our shop!
- The chancellor wrote to Theresa May (she's our Prime Minister!) who was unsure about the cuts to convince her that there were too many pharmacies and that the public would be better served by online pharmacies when they forced traditional pharmacies to close.

The judge mentioned that his next door neighbour has a daughter who is a pharmacist. I'm not sure how this is relevant but I hope the whole profession aren't made to pay if she used to knock her ball into his garden when she was a kid.
